

# Ingleton Waterfalls Trail Photographic Competition 2023/24

## Terms & Conditions

1. The subject for the Photographic Competition 2023/24 is "Ingleton Waterfalls Trail." The theme is open to individual interpretation. The judges will decide on the eligibility of photographs, their decision will be final, and no correspondence will be entered into.
2. Photographs entered must be taken at Ingleton Waterfalls Trail.
3. Entrants can submit up to four photographs in digital format (JPEG) in colour, or black and white. Only one photo by any individual entrant can be included in the final shortlist.
4. Images may be digitally enhanced but not manipulated. Entrants can enhance the photo to make it brighter, clearer etc. but not manipulate the content. The judges reserve the right to exclude any image they believe may have been excessively treated so as to alter its authenticity.
5. The competition is open to UK residents only. Employees of Ingleton Scenery Co Ltd or Ingleton Waterfalls Trail, and their immediate families, are not eligible to enter. Entrants under the age of 12 must have parent or guardian consent to enter.
6. Entrants must not be professional photographers and for the purposes of this competition a professional photographer will be considered to be someone who makes more than half their annual income from the sale of their photographs.
7. Entrants' contact details will only be used for the purposes of administering the competition.

Entries received after this date will not be considered. Ingleton Scenery Co Ltd cannot accept any responsibility for any problem which may result in any entry being lost or delayed. Proof of sending is not proof of receipt. Entries will not be returned. Unsuccessful entrants will not be contacted and no feedback on any entry will be provided.

10. The judges will review all the entries and select a winner in the Adult and Child categories. If after reasonable attempts the winners cannot be contacted the judges reserve the right to offer the place to the next chosen entry.

11. Prizes:

1<sup>st</sup> Prize (Adult Category) Weekend Stay in a Holiday Home at Falls Park, Ingleton (Terms & Conditions apply).

1<sup>st</sup> Prize (Child Category – under 16 years ) £50 Cash.

Additional Prizes - 4 Prizes of £50 Gift Vouchers will be awarded at the end of each season for winning photographs chosen by the judges in the categories of Spring / Summer / Autumn / Winter at Ingleton Waterfalls Trail.

The prizes are as stated and cannot be deferred or transferred. There will be no cash alternatives. The judges' decision will be final and no correspondence can be entered into.

12. All entries must be the original work of the entrant and must not infringe the rights of any other party. The entrants must be the sole owner of copyright in all photographs entered and must have obtained permission of any people featured in the entries, or their parents/guardians if children under 16 are featured. Entrants must not have breached any laws when taking their photographs.
13. Prior to submission, entrants must not have offered any of their entries for sale, been paid for any publication of any of their entries or won or been a runner-up in any other photographic competition with any of their entries.
14. Entrants will retain copyright in the photographs that they submit. By entering the competition, all entrants grant to Ingleton Scenery Co Ltd, the right to publish and exhibit their photographs on the Ingleton Waterfalls Trail website, or in print, or in any other media for advertising and promotional purposes. No fees will be payable for any of the above uses. Entrants whose photographs are one of the finalists also agree to take part in post-competition publicity. Every effort will be made to credit photographers, we cannot guarantee that every use of the photographs will include the photographers' names.
15. By entering, entrants will be deemed to have agreed to be bound by these rules and Ingleton Scenery Co Ltd reserves the right to exclude any entry from the competition at any time and in its absolute discretion if Ingleton Scenery Co Ltd has reason to believe that an entrant has breached these rules.
16. Ingleton Scenery Co Ltd reserves the right to cancel this competition or alter any of the rules at any stage, if deemed necessary in its opinion, and if circumstances arise outside of its control.

17. If the winner is unable to be contacted after reasonable attempts have been made, Ingleton Scenery Co Ltd reserves the right to either offer the prize to a runner-up or to re-offer the prize in any future competition.
